ORDER:

In the reference first read above, among others, orders have been issued granting exemption of Stamp Duties and Registration Fees to Micro and Small manufacturing enterprises. In para 4 of the executive portion of the said Government Order, the terms "Micro and "Small" mentioned in the notifications appended to the said order have been defined.

2. Pursuant to the notification issued by the Ministry of Micro, Small and Medium Enterprises dated 26.06.2020, the Inspector General of Registration in the reference second read above, has sent proposal to modify the definition defined in the Government Order first read above, so as to enhance the monetary limit provided therein.

3. The Government, after careful examination of the proposal of the Inspector General of Registration, issue the following amendment to the G.O.(Ms.)No.1, Commercial Taxes and Registration (J1) Department, dated 06.01.2009, namely:-

AMENDMENT

In the said Government Order, for paragraph 4, the following paragraph shall be substituted, namely:-

"4. The Government also direct that the terms "Micro" and "Small" Enterprises mentioned in the notifications appended to this order shall be construed as per the criteria of monetary limit notified by the Government of India, Ministry of Micro, Small and Medium Enterprises Notification No.S.O.2119(E), published at pages 5-7 of Part-II-Section 3 - Sub-Section (ii) of the Gazette of India, Extraordinary dated the 26th June, 2020, as amended from time to time."


