## **ORDER:**

In the Government order first read above, orders were issued granting exemption from payment of Stamp duty in respect of Agreement relating to Deposit of Title Deeds executed for securing loans availed from Banks and Financial Institutions by Micro, Small and Medium Enterprises under Aatma Nirbhar Bharat Scheme for the period upto 31.3.2021 and also reduction of the Registration fee at 0.1% from 1.0% in respect of registration of Agreement relating to Deposit of Title Deeds on loans and additional loans granted by the Banks and Financial Institutions to Micro, Small and Medium Enterprises.

- 2. In the reference second read above, the Government of India has extended the Aatma Nirbhar Bharat Scheme for a further períod of 6 months upto 30.09.2021.
- 3. In the meantime, in the reference third read above, the Hon'ble Chief Minister has announced among others on 11.5.2021 as follows:-

Based on the above announcement made by the Hon'ble Chief Minister, Government have decided to extend for granting exemption from payment of Stamp Duty in respect of registration of Agreement relating to Deposit of Title Deeds executed for securing loans availed from Banks and Financial Institutions by Micro, Small and Medium Enterprises under Aatma Nirbhar Bharat Scheme as ordered in the Government order first read above, for the period upto 31.12.2021.
