The services of this Laboratory have been accredited by the National Accreditation Board for Testing and Calibration Laboratories (NABL), Department of Science & Technology and recognised by the Bureau of Indian Standards (BIS), Ministry of Consumer Affairs, Government of India.

Quality Control Order Implementation

In order to ensure the availability of quality electrical products in the market for the use of consumers, this Department established Quality Control Order Enforcement Centre to enforce the Household Electrical Appliances (Quality Control) Order, 1981 and the Electrical Wires, Cable, Appliances, and Protection Devices and Accessories (Quality Control) Order, 2003.
