ORDER:

The Government of India in their letter first read above have conveyed the final approval for setting up of Common Facility Centre for Gold Jewellery Cluster, Tiruchirappalli at a total project cost of Rs.360.30 lakh with the following funding pattern:

2. In the Government Order second read above, State Government have released its first instalment grant of Rs.14.412 lakh towards setting up of the above cluster.

3. The Government of India in their sanction order fourth read above conveyed the release of 1st instalment of Rs.1,15,29,600/- being the 40% of the total grant of Rs.288.24 lakh to SIDCO towards setting up of CFC in Gold Jewellery Cluster, Tiruchirappalli for the financial year 2018-19.

4. The Tamil Nadu Small Industries Development Corporation Limited in their letter third read above have requested the Government to sanction Rs.21,61,800/- (Rupees Twenty one lakh sixty one thousand eight hundred only) being the second and final instalment towards State Government contribution to the Gold Jewellery Cluster, Tiruchirappalli under Micro and Small Enterprises - Cluster Development Programme.

The Government after careful examination of the proposal of Tamil Nadu Small Industries Development Corporation Limited accord sanction for a sum of Rs. 21,61,800/- (Rupees Twenty one lakh sixty one thousand eight hundred only) being the second and final instalment of State Government grant for setting up of Common Facility Centre for Gold Jewellery Cluster, Tiruchirappalli under Micro and Small Enterprises - Cluster Development Programme.
