ORDER

The Principal Secretary / Industries Commissioner and Director of Industries and Commerce has stated that during the Budget speech 2017-18 on 16-03-2017 among others it has been stated as follows:

"A special scheme will be launched to promote energy efficiency in MSME units with an allocation of Rs.5.00 crore. Under this scheme, suitable incentives will be given to MSME units based on energy audit."

- 2. He has stated that based on the above Budget announcement, a proposal with draft guidelines for implementation of Promotion of Energy Audit and Conservation of Energy (PEACE) was sent to Government in order to accomplish the above task for promotion of Energy Audit and Energy Conservation. The following components were proposed:
 - a. Awareness Program
 - b. Training Program
 - c. Detailed Energy Audit
 - d. Incentive for Implementing Energy Audit Recommendation

3. The consolidated details of scheme and fund requirement for the above programmes for the three years 2017-18, 2018-19 and 2019-2020 were proposed as follows:-

- 4. The Government have sanctioned a sum of Rs.5,00,00,000/-(Rupees Five crores only) for the year 2017-2018 for extending incentives to MSMEs for implementing energy efficiency measures as detailed at para.5 of the G.O (Ms) No.35, Micro, Small and Medium Enterprises (G) Department, Dated 09.06.2017.
- 5. The General Managers of District Industries Centre / Regional Joint Director, Chennai were requested to furnish the details of PEACE subsidy applications processed and kept ready for disbursement as on 31.03.2018. The General Managers of District Industries Centre/ Regional Joint Director, Chennai have furnished the details and it is found that funds to the tune of Rs.1.87 lakhs is required for clearing pending application with them kept ready for disbursement of Promotion of Energy Audit and Conservation of Energy (PEACE) subsidy for the period upto 31.03.2018 and Rs.239.24 lakhs for applications anticipated upto 30.09.2018. - 6. The Principal Secretary / Industries Commissioner and Director of Industries and Commerce has requested to accord administrative sanction for an amount of Rs.3,50,00,000/- (Rupees Three crores and fifty lakhs only) besides authorising the Principal Secretary / Industries Commissioner and Director of Industries and Commerce to draw and disburse the amount mentioned in para 5 above, to all General Managers of District Industries Centres / Regional Joint Director, Chennai by relaxing the quarterly control appropriation system.
- 7. The Government after careful examination of the proposal of the Principal Secretary / Industries Commissioner and Director of Industries and Commerce have decided to accord administrative and financial sanction for an amount of Rs.3,50,00,000/- (Rupees Three crores and fifty lakhs only) besides authorising the Principal Secretary / Industries Commissioner and Director of Industries and Commerce to draw and disburse the amount mentioned in para 5 above to all General Managers of District Industries Centres / Regional Joint Director, Chennai by relaxing the quarterly control appropriation system for implementation of Promotion of Energy Audit and Conservation of Energy (PEACE) for which orders have been issued in the G.O (Ms) No.114, Finance (BG-1) Department, dated 28.03.2018.
